## SUBPART- A General

## **183.1 Scope.**

This part prescribes the requirements for designating persons to act as representatives of the Chief Commissioner of Civil Aviation Regulatory Commission (CEO ) to examine, inspect and test persons, aircraft, airports, aviation facilities and agencies for the purpose of issuing airman , aircraft, airport and aviation agency certificates as appropriate, and for engineering representatives with respect to recommending the approvals of aircraft and airport facilities engineering design installations and/or design changes and obstacles limitation surfaces, and for environmental representatives with respect to conducting environmental studies and impact assessment. In addition, this part also states the functions and limitations of those representatives and prescribes the rules for exercising those functions.

# SUBPART- B Certification of Representatives

## 183.5 Selection.

- (a) Aviation medical examiners.
  - (1) Chief Commissioner/CEO may nominate designated aviation medical examiners, qualified and licensed in the practice of medicine to conduct medical examinations of fitness of applicants for the issuance or renewal of the medical certificate or rating.
  - (2) Medical examiners shall have or receive training in aviation medicine.
- (b) Pilot, flight instructor, and flight engineer examiners.

Chief Commissioner/CEO may nominate pilot, flight instructor and flight engineer examiners, as may be needed, who are deemed suitable and qualified to conduct examinations of knowledge, skill, and competency in accordance with JCAR parts 61,63 and 65.

(c) Aircraft mechanic, air traffic control operator, aircraft dispatcher and parachute rigger examiners.

Chief Commissioner/CEO may nominate aircraft mechanic, air traffic control operator, aircraft dispatcher and parachute rigger examiners, as may be needed, who are deemed suitable and qualified to conduct examinations of knowledge, skill, and competency in accordance with JCAR part 65.

(d) Aircraft engineering representatives.

Chief Commissioner/CEO may nominate engineering representatives, as may be needed, who are suitable and qualified to perform engineering analysis of airworthiness design and design changes for compliance with airworthiness requirements of applicable standards and regulations.

Such designations will be known as:

- (1) Aircraft structural engineering representatives
- (2) Powerplant engineering representatives;
- (3) Aircraft systems and equipment engineering representatives; and
- (4) Radio and avionics systems engineering representatives.
- (e) Airport Engineering representatives.

Chief Commissioner/CEO may nominate engineering representatives, as may be needed, who are suitable and qualified to perform engineering analysis of airport physical characteristic or airfield visual aids or obstacle limitations surfaces for compliance with applicable standards and regulations, such designations will be known as:

- (1) Airport physical characteristic representative.
- (2) Airport visual aids representative.
- (3) Obstacle evaluation representative.
- (f) Airport operations safety representatives.

Chief Commissioner/CEO may nominate airport operation representatives, as may be needed, who are suitable and qualified to perform operations analysis, evaluation and certification of apron operations, fire fighting and fuel handling functions for compliance with applicable standards and regulations , such designations will be known as:

- (1) Apron operation representative.
- (2) Rescue and fire fighting representative.
- (3) Fuel handling representative.
- (g) Airport environmental protection representatives.

Chief Commissioner/CEO may nominate experts as may be needed, who are suitable and qualified to performance environmental protection; analysis and carry out environmental impact studies at airports for compliance with applicable standards and regulations, such designation will be known as:

- (1) Noise evaluation representative.
- (2) Environmental impact assessment representative.
- (3) Wildlife hazard assessment representative
- (h) Cabin crew examiners.

Chief Commissioner/CEO may designate cabin crew examiners, as may be needed, who are deemed suitable and qualified to conduct examinations of knowledge, skill, and competency in accordance with JCARs part 63.61 and part 121.417

#### 183.7 Certification.

- (a) A Certificate of Designation and a Certificate of Authority will be issued by Chief Commissioner/CEO to each representative appointed to perform specified functions for the CARC.
- (b) The Certificate of Designation will show the basic functions which the designee is qualified and authorized to perform. The Certificate of Authority will show the designee's specific qualifications and authorizations

#### 183.9 Duration of certificates.

- (a) All representatives are designated for a one year period and all examiners must have their authority renewed before 12 months, after the date of issuance or subsequent renewal.
- (b) A designation made under this subpart shall otherwise terminate whenever:
  - (1) Requested in writing by the designee; and approved by Chief Commissioner/CEO.
  - (2) Requested in writing by the designee's employer for any designation in which the recommendation of the employer is required for the designation;
  - (3) The designee is separated from the employment of the employer who recommended that designee for certification;
  - (4) Chief Commissioner/CEO finds that the designee has not properly performed his duties under the terms of the designation;
  - (5) Chief Commissioner/CEO, for any reason, deems it appropriate to terminate the designation.

# **183.11 Reports.**

Each representative designated under this part shall make such reports as may be prescribed by Chief Commissioner/CEO .

# **SUBPART-** C Functions and Responsibilities

## 183.17 Aviation medical examiners.

An aviation medical examiner as authorized by their designations:

- (a) May accept applications and perform physical examinations necessary for issuing medical certificates as required for airman certification under JCARs parts 61,63,65 and in accordance with the applicable medical standards.
- (b) Issue or deny medical certificates or waivers thereto subject to review by the Aviation Medical Division -Civil Aviation Regulatory Commission.

## 183.19 Pilot, flight instructor, and flight engineer examiners.

Pilot, flight instructor, and flight engineer examiners as authorized by their designations:

- (a) May accept applications for oral and flight tests required for the issuance of pilot certificates and ratings, flight instructor certificates and ratings and flight engineer certificates and ratings, as prescribed in JCAR parts 61,63,and
- (b) Shall conduct flight tests as authorized in their certificates of designation and authorization.

# 183.21 Aircraft mechanic, aircraft dispatcher, air traffic controller, and parachute rigger examiners.

Aircraft mechanic, aircraft dispatcher, air traffic controller, and parachute rigger examiners as authorized by their designations:

- (a) May accept applications for oral and practical tests required for the issuance of aircraft mechanic certificates and ratings, air traffic controller certificates and ratings, aircraft dispatcher certificates and ratings and parachute rigger certificates and ratings as prescribed in JCAR parts 63 and 65.
- (b) Shall Conduct those tests as authorized in their certificates of designation and authorization.

# 183.23 Aircraft engineering representatives.

Aircraft engineering representatives as authorized by their designations:

- (a) May recommend approval of airworthiness design and design changes, installations, and any required airplane flight manual changes in accordance with standards set forth in these regulations and as otherwise established by the Civil Aviation Regulatory Commission for aircraft structures, powerplants, aircraft systems and equipment; and radio and avionics systems.
- (b) Shall perform only functions within the scope of the authorizations accorded in their respective designations.

## 183.25 Airport engineering representatives.

Airport engineering representatives as authorized by their designations:

- (a) May recommend approval of airport physical characteristics, airfield visual aids design and design changes ,as well as installations and obstacle limitation surfaces in addition to evaluate obstructions in accordance with standards set forth in JCAR and as otherwise established by the Civil Aviation Regulatory Commission for airport systems and equipment standards.
- (b) Accept applications for oral and practical tests required for the issuance of airport technical competency certificates and ratings as prescribed in JCAR part 65.
- (c) Shall perform only functions within the scope of the authorizations accorded in their respective designations.

## 183.27 Airport operation safety representatives.

Airport operation safety representatives as authorized by their designations:

- (a) Recommend approval of apron operating procedures, fire fighting capabilities and fuel handling operations in accordance with standards and recommended practices set forth in JCAR and as otherwise established by the Civil Aviation Regulatory Commission to comply with the requirements of the regulations.
- (b) Accept applications for oral and practical tests required for the issuance of airport operational competency certificates and ratings as prescribed in JCAR part 65.
- (c) Airport operation safety representatives shall perform only functions within the scope of the authorizations accorded in their respective designations.

# 183.29 Airport environmental protection representatives.

Airport environmental protection representatives as authorized by their designations;

- (a) May recommend approval of airport's environmental protection methods, procedures and restrictions for noise, environmental impact studies and wildlife management plans at the airport in accordance with standards and recommended practices set forth in JCAR and as otherwise established by the Civil Aviation Regulatory Commission to comply with the requirements of the regulations.
- (b) Shall perform only the function within the scope of the authorization accorded in their respective designations.

## 183.31 Cabin crew examiners.

- (a) Recommend approval of competency clearance of newly hired cabin crew trainee.
- (b) Shall conduct oral and practical tests for cabin crew to determine their knowledge, skill and compliance in accordance with JCAR Part 63.61
